Terms of Reference (TOR) for engagement of Prosecution Liaison Officers on contractual basis in the Vigilance Organisation.

1. Job Description :-

- (a) Posts:- 06 (Six).
- (b) Suitable retired Vigilance/Police Officers in the rank of Inspector of Police and above having 10 years or more experience in investigation/ prosecution matters will be engaged as Prosecution Liaison Officer in the Vigilance Organisation on contractual basis with consolidated remuneration of Rs.25,000/- (Rupees Twenty Five thousand)only per month. They may be required to discharge their duties at any of the following places, namely, Berhampur, Keonjhar, Balasore, Sundargarh, Bolangir and Koraput (Jeypore). Candidates interested for posting other than at the above six places need not apply.

2. Aims and Objectives :-

- (a) To manage and monitor the day to day work of prosecution of cases and report the same on a daily basis to Divisional SP/ Unit DSP and in important cases to Prosecution Cell of Vigilance Directorate, Cuttack.
- (b) To collect and furnish present address of witnesses in all the year old cases under trial.
- (c) To serve summons to the witnesses in their present address so as to procure their attendance on the dates fixed for trial and ensure return of the summons after their service to the witnesses well before the next date of trial.
- (d) To assist the Special Public Prosecutor in prosecution related matters.
- (e) To ensure attendance of the witnesses and investigating officers by being in constant touch with them.
- (f) To perform such other duties as and when assigned by the competent authority.

3. Eligibility Criteria:-

(a) Retired Vigilance/Police Officers in the rank of Inspector of Police and above (having 10 years or more experience in Investigation/ Prosecution matters) who have retired from Govt. Service on attaining the age of superannuation and not above the age of 63 years as on the closing date of advertisement are eligible to apply.

- (b) Applicants against whom departmental proceeding or Vigilance or criminal case is contemplated or pending or who has been penalized for misconduct during the period of preceding five years from the date of superannuation or who has been convicted by a Court of Law, will not be considered for engagement.
- (c) Working computer knowledge is desirable.

4. Tenure, Terms and Conditions :-

- (a) The engagement will be made initially for a period of one year which may be extended or curtailed based on performance assessment and further approval of the Government, but not beyond sixty-five (65) years of age in any case.
- (b) The retired officers will be engaged on contractual basis with consolidated remuneration of Rs.25,000/- (Rupees Twenty Five thousand) only per month.
- (c) They will not be eligible for Dearness Allowance or any other Special Pay or Allowance over and above the consolidated remuneration.
- (d) They will be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and will be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (e) They will be required to maintain utmost confidentiality and integrity in their conduct.
- (f) This engagement can be terminated at any time by the Director, Vigilance on grounds of unsatisfactory performance or in case of any misconduct, misappropriation, negligence or causing loss to Government or any breach of conduct by the engaged officer or indictment in a Court of Law, by giving 1(one) month notice. Such termination of his/her engagement may further debar him/her from further engagement in the Department. Conversely, if any engaged Prosecution Liaison Officer desires to resign, he/she shall do so by giving 1(one) month's written notice to the Director, Vigilance.

5. Selection Process:-

The selection for the required posts will be made by a Selection Committee as decided by the Director, Vigilance.
