A. Qualification:

* for SFC Courses

The eligibility criteria are the same as for Assistant Professor in the mentioned subjects as laid down in para 4 of the UGC Regulations, 2018 published in the Gazette of India (as amended from time to time). i.e. the candidates must have possessed 55% mark or equivalent grade of P.G. Level in concerned/relevant subject with NET qualification. The candidate with higher qualification/ experience and publications will be given preference.

* for Contemporary Art Courses

The candidates must have possessed minimum qualification of Master Degree or equivalent qualifications in Percussion (Mardala) Player, Vocal (Odissi), Flute Player (All accompany for Odissi Dance) with certificate from any recognized Govt. Institutions. The candidate with higher qualification/ experience will be given preference.

B. Nature of Post & Remuneration.
